**COMPREHENSIVE PLAN ADOPTION
SEQR DECLARATION OF INTENT TO BE
LEAD AGENCY
April 28, 2025**

At a regular meeting of the Board of Trustees of the Village of Marcellus, Onondaga County, New York held at the Village Hall, 6 Slocombe Avenue, Marcellus, New York, on April 28, 2025, at 7:00 p.m. prevailing time:

The meeting was called to order by Mayor Chad A. Clark, and upon roll call, the following were present:

The following Resolution was offered by Trustee Curtin, who moved for its adoption, seconded by Trustee Manahan, to wit:

WHEREAS, the Village of Marcellus Village Board (hereinafter referred to as "Village Board") has reviewed the New York State Environmental Quality Review Act ("SEQRA") Full Environmental Assessment Form ("EAF") Part 1, prepared by the MRB Group on the above-referenced Village of Marcellus Comprehensive Plan (hereinafter referred to as "Action"); and

WHEREAS, the Village Board determines that said Action is classified as a Type 1 Action under the State Environmental Quality Review ("SEQR") Regulations; and

WHEREAS, the Village Board determines that said Action is also subject to review and approval by other involved agencies under the SEQR Regulations; and

WHEREAS, the Village Board determines that it is the most appropriate agency to ensure the coordination of this Action and will provide written notifications to interested agencies for the purposes of conducting a coordinated review and making the determination of significance thereon under the SEQR Regulations.

NOW, THEREFORE BE IT RESOLVED that the Village Board does hereby declare its intent to be designated as the lead agency for the Action and directs the Village Mayor to sign and date the Full EAF Part 1.

BE IT FURTHER RESOLVED, MRB Group is directed to provide notice hereof to the involved and interested agencies, seeking their agreement (or objection thereto) in writing on or before noon on Wednesday, May 28th, 2025.

The question of the adoption of the foregoing resolution was duly put to a vote on roll call, which resulted as follows:

The resolution was thereupon declared duly adopted.


