

# PROCLAMATION

At a regular meeting of the Board of Trustees of the Village of Marcellus, Onondaga County, New York, held at the Village Hall, 6 Slocombe Avenue, Marcellus, New York, on the 27<sup>th</sup> day of June 2022, at 7:00 p.m., Eastern Time.

The meeting was called to order by Mayor John P. Curtin, and upon roll being called, the following were present:
